Lakeshore Tennis Key process:

Step 1: Pay online

Step 2: Tennis Key Holder application

- **Option 1:** For your convenience, the 2024 Tennis & Pickleball Courts Facility Use Permit is attached. Print and complete this permit, then bring it with you to the Atlas Tube Recreation Centre to pick up your key.
- **Option 2:** We also have copies of the this permit at the Atlas Tube Recreation Centre Front Desk for those who would like to fill this out on site.

Step 3: Pick up your key

To pick up your key, please visit the Atlas Tube Recreation Centre. Keys can be picked up during the following hours:

- Monday to Sunday from 6:00 AM to 8:00 PM
- PLEASE NOTE: The Atlas Tube Recreation Centre will be closed on Victoria Day (May 20), Canada Day (July 1), Civic Holiday (August 5) and Labour Day (September 2)

Step 4: Go out and enjoy some tennis or pickleball!

This permit entitles the Permit Holder a non-exclusive, non-transferrable permit to use the Municipality of Lakeshore's Tennis and Pickleball Courts ("Facility") for the 2024 Season (April 8th to October 31st, 2024, weather pending) located at:

1) By accepting the keys to the Lakeshore Tennis/Pickleball Courts (the "Facility"), I agree:

- a. To pay the non-refundable User Fee for use of the Facility in accordance with the Municipality's User Fee By-law;
- b. To use the Facility only for the purpose of playing tennis or pickleball and for no other purpose;
- c. To comply with the Court Rules posted at the Facility and on the Municipality's website.
- d. To pay \$5.50 for replacement of the keys if lost or destroyed while in my custody;

- e. TO RELEASE, WAIVE AND FOREVER DISCHARGE THE MUNICIPALITY OF LAKESHORE, ITS EMPLOYEES, ELECTED AND NON-ELECTED OFFICIALS, AGENTS, CONTRACTORS, SUCCESSORS AND ASSIGNS FROM ANY AND ALL CLAIMS, DEMANDS, DAMAGES, LOSSES, EXPENSES, ACTIONS, CAUSES OF ACTION AND ACTIONS WHATSOEVER WHETHER IN LAW OR EQUITY IN RESPECT OF DEATH, INJURY, LOSS OR DAMAGE TO THE PERMIT HOLDER, THE PERMIT HOLDER'S GUESTS OR THE PROPERTY OF THE PERMIT HOLDER OR GUESTS HOWSOEVER CAUSED.
- f. That I will not participate in sporting activities, including tennis or pickleball, if not physically fit to do so and will not permit my Guests to do so either;
- g. That I will advise persons that accompany me to the Facility ("Guests") that their use of the Facility constitutes agreement of the terms and conditions of this Permit, including
 - That I am 18 years old or older;
 - That I will not loan or otherwise transfer possession of the Facility Key or this Permit;
 - That the Municipality is not required to supply equipment for my use or the use of my Guests;
- h. Agree to securely close the gate and lock the Facility after completion of use of the Facility;
- i. Agree to report any damage which I or my guests may cause or permit to be caused or that we have observed at the Facility;
- j. Agree to remove any items that I or my guests bring to the Facility and deposit garbage or refuse in the trash bins provided;
- k. That breach of the terms and conditions of this Permit:
 - l. May result in the suspension, revocation and refusal of future Municipality of Lakeshore future Facility Permits, including but not limited to this facility or other Municipal facilities.
- m. This Permit is valid for the Season, unless otherwise revoked or suspended by the Municipality;
- n. This Permit is not valid for any other Facility than the facility identified in the Permit and does not constitute approval for use of any other Municipal facility;
- o. The Municipality reserves the right to update or modify the terms of this Permit, including the Court Rules, at any time without prior notice to me;

- p.** The continued use of this Permit, after the Municipality provides you with a change notice, constitutes your agreement to be bound by the revised terms. Whenever the terms are changed, the effective date of the change will be the date upon which notice is given;
- q.** That the information provided in my application for this Permit is true and accurate to the best of my knowledge;
- r.** To consent to the collection of my personal information provided in this application for the purpose of processing my application for a Facility Use Permit in accordance with the Municipal Act, 2001 and understand that questions regarding the collection of my personal information for this purpose may be directed to the Division Leader – Community Services for The Municipality of Lakeshore at the phone number and address listed below;
- s.** That reproduction of this Permit is prohibited; and
- t.** That this Permit is governed by the laws of the Province of Ontario and that I attorn to the jurisdiction of the courts of the Province.

Our goal is to ensure the court and surface are protected. Contact the Lakeshore Community Services Division at 519-728-27000 in the event of damage/vandalism or if the condition of the court requires attention.

- No skateboards, bicycles, skates, or rollerblades on the courts
- Proper attire required
- Please lock the gate when you are finished
- No food, drinks, alcohol, tobacco, or drugs on the courts (Water only)
- No profanity. Please use trash bins provided
- Do not abuse the net or other equipment (Report vandalism or damage)
